

**No. 182.****THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES)  
CONSOLIDATION ORDERS, 1940 TO 1942.****NOTICE No. 106 UNDER CLAUSE 13.**

A.—The Schedule is hereby amended by the deletion therefrom of Part 36 and the substitution therefor of the following :—

**“PART 36.—POTATOES.**

| (1)      | (2)                | (3)                 |

|          | Retail Price       | Wholesale Price     |
| Potatoes | 5 piastres per oke | 4 piastres per oke. |

*Limitation* : All persons having in their possession or under their control more than 200 okes of potatoes shall sell only at wholesale prices.

In this part of the Schedule—

the term ‘wholesale’ means sale or purchase of potatoes in quantities of not less than 40 okes at any one time or at any single transaction.”

B.—The Schedule is hereby amended by the addition thereto of the following part :—

**“PART 73.—THRESHING BOARDS (DOUGANES).**
