

**No. 184. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.****ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as a Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This order may be cited as the Defence (Chick Peas, Movement and Control) Order, 1943.

2. For the purposes of this order—

“Local Purchases Officer” means any person or body of persons appointed under the Defence (Returns of Agricultural Produce) Order, 1943.

“Producer” means the owner or occupier of any land sown with chick peas for the 1943 harvest.

3. Every producer in the districts of Paphos and Nicosia, with the exception of producers in the villages set out in the Schedule to the Defence (Returns of Agricultural Produce) Order, 1943, shall, on or before the 5th June, 1943, deliver to the Local Purchases Officer of the town or village in which the chick peas are grown a signed declaration setting out the number of donums of chick peas sown by him for the 1943 harvest.

4. No producer shall sell, offer for sale, attempt to sell or make any arrangements to sell either directly or indirectly any chick peas save under a permit in writing given under my hand and subject to such conditions as may be contained in the permit.

5. Any person who acts in contravention of the provisions of this order or of any condition in any permit issued under the provisions of this order, is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 1) 1943.
