

No. 223. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.**ORDER MADE UNDER REGULATION 2.**

I, the Governor, in exercise of the powers conferred by regulation 2 of the Defence Regulations, 1940 to (No. 1) 1943, do hereby order as follows:—

1. This Order may be cited as the Defence (Essential Services) (Dock Labour) Order, 1943, and shall come into operation on and from the date of its publication in the *Gazette*.

2. The following services are declared to be of public utility or to be essential for the prosecution of the war or essential to the life of the community, that is to say:—

Services at docks in connection with the loading or unloading of vessels and all other services connected therewith, including the removal of any goods from the docks.

No. 224. THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.**ORDER MADE UNDER SECTION 13 (2).**

No. 226. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.**ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This order may be cited as the Defence (Control of Local Fleece Wool) Amendment Order, 1943, and shall be read as one with the Defence (Control of Local Fleece Wool) Order, 1943, (hereinafter referred to as "the principal Order"), and the principal Order and this order may together be cited as the Defence (Control of Local Fleece Wool) Orders, 1943.

2. The principal Order is hereby amended by the deletion therefrom of clauses 3 and 4 and the substitution therefor of the following clauses respectively:—

"3. Not later than seven days after the last day of each month, commencing from the month of June, 1943, every person who has in his possession or under his control any local fleece wool in excess of 100 okes shall complete and deliver to me a return of the local fleece wool in his possession or under his control, in the form set forth in the Second Schedule hereto.

4.—(1) From and after the 24th day of June, 1943, no person who has in his possession or under his control any quantity of local fleece wool in excess of the quantity mentioned in clause 3 of this order shall manufacture into any article, make use of, sell or expose for sale or otherwise dispose of, any local fleece wool save under a special permit issued under my hand.

(2) Every special permit issued under the provisions of sub-clause (1) hereof may contain such terms and conditions as may be specified therein".
