**No. 228. THE CUSTOMS LAWS, 1936 TO (No. 2) 1942.**

**ORDER IN COUNCIL No. 2086**  
**MADE UNDER SECTIONS 52 AND 65.**

I, the Governor in Council, in exercise of the powers conferred by sections 52 and 65 of the Customs Laws, 1936 to (No. 2) 1942, do hereby order as follows:—

1. This order may be cited as the Import Duty and Wharfage Dues (Exemption of Certain Articles) (Allied Nations) Order, 1943.
2. For the purposes of this order "Allied Nation" means any nation in alliance with His Majesty in the present war.
3. All articles imported into the Colony consigned to members of the armed forces of any Allied Nation which are intended for their personal or official use and all personal effects and equipment accompanying them on arrival shall be admitted into the Colony free from all import duties and wharfage dues.

**No. 229. THE CUSTOMS (EXPORT DUTY) LAW, 1940.**

I, the Governor in Council, in exercise of the powers conferred by section 5 of the Customs (Export Duty) Law, 1940, do hereby order as follows:—

1. This Order may be cited as the Customs (Export Duty) Schedule Amendment (No. 2) Order, 1943.
2. The Schedule to the Customs (Export Duty) Law, 1940, is hereby amended by the deletion therefrom of items 8 and 8A and the substitution therefor of the following items respectively:—

"S. Spirits .. .. .	15 per centum <i>ad valorem</i> .
8A. Wine .. .. .	10 per centum <i>ad valorem</i> ."

3. The Customs (Export Duty) Schedule Amendment Order, 1943, is hereby

**No. 230. THE ADVOCATES LAWS, 1933 TO 1940.**

**AUTHORIZATION UNDER SECTION 12.**

In exercise of the powers vested in me by section 12 of the Advocates Laws, 1933 to 1940, I hereby authorize the District Inspector and the Assistant District Inspectors of Morphou and Lefka in the District of Nicosia to appear, plead and act on behalf of the Chairman of the Summer Resort Development Boards of Kakopetria, Kalopanayiotis and Pedhoulas in all legal proceedings instituted under the Summer Resorts (Development) Law, 1938, or any bye-laws made thereunder by any of the above-mentioned Boards.

2. The authorizations published under Notification No. 37 in Supplement No. 3 of the *Gazette* of the 31st January, 1940, are hereby revoked.
