NOTICE No. 111 UNDER CLAUSE 13.

The Schedule is hereby amended with effect as from the 24th May, 1943, by the deletion therefrom of Parts 10, 13 and 39 and the substitution therefor of the following respectively :—

"PART 10.—BROAD BEANS.

In this part of the Schedule—
the term 'wholesale' means sale or purchase of chickpeas in quantities in excess of 40 okes at any one time or at any single transaction.

No. 232. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows :—

1. This order may be cited as the Defence (Control of Local Hides and Local Leather) (Amendment) Order, 1943, and shall be read as one with the Defence (Control of Local Hides and Local Leather) Orders, 1942, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Control of Local Hides and Local Leather) Orders, 1942 and 1943.

2. Clause 8 of the principal Order is hereby revoked.

3. Sub-clause (1) of clause 10 of the principal Order is hereby deleted and the following sub-clause substituted therefor :—

"(1) Every butcher, not being a licensed dealer, shall, within the times specified in sub-clause (2) of this clause, after the slaughter :—

(a) of any goat, she-goat, lamb or kid, dispose of the hide of such animal to a licensed dealer;

(b) of any cow, ox, calf or heifer, sell the hide of such animal to the Leather Control Board or its duly authorized Agent, and remove or cause such hide to be removed to a place of storage licensed by or on behalf of the Leather Control Board."
