No. 256. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

ORDER MADE UNDER REGULATION 55 (1).

In exercise of the powers vested in the Governor under paragraph (1) of regulation 55 of the Defence Regulations, 1940 to (No. 1) 1943, duly deputed to me under paragraph (2) of the said regulation, I do hereby order as follows:-

- 1. This Order may be cited as the Control of Transport (Speed Limits of Mechanical Vehicles) Order, 1943.
 - 2. For the purposes of this Order:-
 - "mechanical vehicle" means any vehicle propelled on the road by a mechanical prime-mover.
- 3. From and after the publication of this Order in the Gazette the following speed limits shall be observed by the following types of mechanical vehicles driven on any highway outside the limits of any town or village wherein a Municipal Corporation is established, that is to say :-
 - (a) taxis, private cars and motor cycles, maximum speed 35 miles per hour;
 - (b) any other type of mechanical vehicle not specified in paragraph (a) above, maximum speed 25 miles per hour.
- 4. Any person who acts in contravention of this Order is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 1) 1943.
- 5. Nothing in this Order contained shall affect the operation of any regulations in force for the time being, made under the Motor Car Laws, 1921 to 1936.

No. 257. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as a Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:-

1. This Order may be cited as the Defence (Agricultural Produce Movement Gazette: and Control) (Amendment) Order, 1943, and shall be read as one with the Defence Supplement (Agricultural Produce Movement and Control) Order, 1943, (hereinafter referred No. 3: to as "the principal Order") and the principal Order and this Order may together be 22.4.1943 cited as the Defence (Agricultural Produce Movement and Control) Orders, 1943.

- 2. Clause 1 of the principal Order is hereby amended by the deletion therefrom of the words "and the expressions 'Agricultural Produce' and 'Local Purchases Officer' in this order shall have respectively the same meaning as in the said order", appearing in lines 3, 4 and 5 thereof.
- 3. The principal Order is hereby amended by the insertion immediately after clause 1 of the following clause:-
 - ." la. For the purposes of this Order:-
 - 'Agricultural Produce' means wheat and barley;
 - 'Local Purchases Officer' means any person or body of persons whom I may appoint as such or whom I have appointed as such under the provisions of the Defence (Returns of Agricultural Produce) Order, 1943.
