THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943. No. 296.

Order made by the Competent Authority under Regulation 61. In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows :-

1. This Order may be cited as the Defence (Returns of Stocks of New Shoes and Boots) Order, 1943. 2. In this Order-"shoes" mea

means men's, women's and children's shoes made of leather or

canvas and leather and includes sandals and slippers (pantoufles); "boots" means men's, women's and children's boots made of leather or canvas and leather and includes "podhines" either "franjidhes" or "tsangarissimes ".

3. Within seven days from the publication of this Order in the Gazette, every person who has in his possession or under his control any new shoes or boots
