

3. The Director of Education shall be in charge of the administration and control of the Reformatory.

4.—(1) The Reformatory shall be managed by a resident Director assisted by such other masters and mistresses as may be appointed by the Governor from time to time.

(2) The Director and any other person appointed under paragraph (1) of this regulation shall comply with any directions or instructions which they may receive from the Director of Education.

5.—(1) There shall be constituted a Board of Visitors to the Reformatory consisting of the Director of Education, the Director of Medical Services and the Commissioner of Nicosia.

(2) The Board of Visitors shall meet at such times and shall perform such duties with reference to the maintenance of good order and discipline in the Reformatory as they may think fit.

**No. 313. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.**

**DELEGATION OF POWERS UNDER PARAGRAPH (5) OF REGULATION 66.**

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 1) 1943, do hereby depute the Commissioner of each District to exercise and perform on my behalf the power to requisition any wreck within the meaning of the Wrecks Law, 1886, and the powers connected with such requisitioning conferred by paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 1) 1943, which I am empowered to exercise and perform thereunder.

**ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**
