### ORDER IN COUNCIL No. 2072

1. This Order may be cited as the Customs (Export Duty) Schedule Amendment

Order, 1943.
2. The Schedule to the Customs (Export Duty) Law, 1940, is hereby amended as follows:-

(a) by the deletion therefrom of the figure "5" in the third column of item 8 thereof and the substitution therefor of the figure "10";

(b) by the insertion therein immediately after item 8 of the following item:—
"8A. Wine .. .. . . . . . . . . . 5 per centum ad valorem.". 5 per centum ad valorem.

#### AUTHORIZATIONS GRANTED UNDER SECTION 4.
