# THE ESSENTIAL WORKS ORDER, 1943.

## Order under Clause 2.

Declaration of Essential Works.

1. The Order published in Supplement No. 3 to the Gazette of the 26th August, 1943, under Notification No. 308, (declaring certain works to be essential works for the purposes of the Essential Works Order, 1943) is hereby amended by the "(f) All works and services in connection with the milling of barley and wheat and the baking of bread by bakers licensed under the Defence (Control of Bakeries and Bread) Orders, 1942 and 1943, or under any order amending or substituted for the same ".

# No. 333. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

Delegation of Powers under Paragraph (5) of Regulation 66.

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 1) 1943, do hereby depute the persons for the time being holding the offices designated in the second column of the Schedule hereto to exercise and perform on my behalf the powers mentioned in the first column of the said Schedule which I am empowered to exercise and perform under the provisions of paragraphs (1). (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 1) 1943.

2. The Orders published in Supplement No. 3 to the *Gazettes* of the 28th May, 1942, and the 5th November, 1942, under Notifications Nos. 189 and 440, respectively, are hereby revoked without prejudice to anything done thereunder.
