THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This Order may be cited as the Control of Cattle and Meat (Liveweight and Carcass Weight Prices) (Amendment No. 2) Order, 1943, and shall be read as one with the Control of Cattle and Meat (Liveweight and Carcass Weight Prices) Orders, 1942 to 1943 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Control of Cattle and Meat (Liveweight and Carcass Weight Prices) Orders, 1942 to (No. 2) 1943.
2. The Schedule to the principal Order is hereby amended by the deletion therefrom of Part I and the substitution therefor of the following:—

THE CONTAGIOUS DISEASES (ANIMALS) LAW, 1880.

NOTIFICATION MADE UNDER SECTION 3.
