LIMITS OF THE MUNICIPAL CORPORATION OF NICOSIA.

Notice under Section 6.

I, the Governor, in exercise of the powers conferred by section 6 of the Municipal Corporations Laws, 1930 to 1943, do hereby declare that from and after the 1st day of November, 1943, the limits of the Municipal Corporation of Nicosia shall be as set forth in the Schedule hereto and that the limits of the said Corporation as set out in the Order in Council, No. 961 dated the 17th November, 1923, and published under Notification No. 573 in the *Gazette* of the 23rd November, 1924, and published under Notification No. 110 in the *Gazette* of the 29th February, 1924, and in the notice published in the *Gazette* of the 23rd September, 1938, under Notification No. 180, as a mended by subsequent notices, shall be cancelled.

SCHEDULE

The boundary commences on the south-western side of the main road from Nicosia to Kyrenia where it is crossed by the road from the tannery near the Golf Course to the village of Trakhonas, and proceeds not 1-eastwards along the western side of the latter road to a point due west of the north-western corner of plot No. 15, Block A, Trakhonas; thence eastwards along the northern boundary of this plot to its north-eastern corner on the main road from the village of Trakhonas to Nicosia; thence south-eastwards for a distance of 100 feet approximately along the said road to the north-western corner of plot No. 16, Block A, Trakhonas; thence eastwards and southwards along the northern and eastern boundaries of the said plot and the northern boundary of plot No. 17 of the said Block to the north-eastern corner of the said plot No. 17; thence southwards, eastwards and southwards following the boundaries of and including plots Nos. 17, 19, 21, 27, 40, 52, 53 and 54 cf Block A, Trakhonas, to the most eastern point of the said plot No. 54; thence eastwards in a straight line for a distance of 130 feet approximately to the point cn the western boundary of plot No. 13, Block B, Omorphita, 120 feet south of the north-western corner of this plot; thence southwards along the boundaries of but excluding plots Nos. 13, 14, 16 and 17 of Block B, Omorphita, to the southeastern corner of the said plot No. 17 on a road which forms the northern boundary of the Nicosia Railway Station ; thence eastwards along the northern side of the said road to the eastern side of the main road from the village of Omorphita to Nicosia; thence south-westwards along the eastern side of the said main road to the boundary of the village of Omorphita; thence eastwards along the southern side of the said railway to the most northern point of plot No. 131, Block B, Omorphita, on the main road from the village of Omorphita to the village of Palouriotissa; thence south-eastwards along the eastern side of the said main road to the cross-roads at the most northern point of plot No. 40, Block A, Palouriotissa; thence southwestwards along the eastern side of the road from the village of Beuyuk Kainakli to the Famagusta Gate of Nicosia to the junction of roads at the south-western corner of plot No. 137, Block A, Palouriotissa; thence southwards along the eastern side of the road leading to the main road from Nicosia to Kythrea to the southwestern corner of plot No. 62 of the said Block ; thence south eastwards in a straight line to the most northern point of the Turkish Cemetery (plot No. 4, Block 23, Taht-el-Kale Quarter); thence south-westwards along the eastern side of the said Turkish Cemetery to the main road from Famagusta Gate of Nicosia to Lamaca; thence south eastwards along the northern side of the said main road to the crossroads at the most northern point of plot No. 24, Block D, Palouriotissa; thence southwards along the eastern side of the road to the Isolation Hospital to the northwestern corner of plot No. 95, Block D, Palouriotissa; thence westwards along the southern side of the road leading to the main road from the Ayios Antonios School to Larnaca; thence south-eastwards along the eastern side of the said main road to the cross-roads at the north-eastern corner of the Mental Hospital; thence westwards along the southern side of the road bounding the said hospital to the main road from the old Nicosia Greek Cemetery to Larnaca; thence south-eastwards along the eastern side of the said main road to the north-eastern corner of the Evghenia Theodotou Orphanage (plot No. 233, Block B, Ayii Omoloyitadhes); thence westwards along the southern boundary of the road from Ayia Paraskevi to the village of Ayii Omoloyitadhes to the most northern point of plot No. 60, Block B, Ayii Omoloyitadhes, on the main road from the village of Palouriotissa to the village of Strovolos; thence south-westwards along the eastern side of the said main road to the Strovolos bridge, on the boundary of the village of Strovolos ; thence northwards along the said village boundary and along the boundary of the village of Engomi (including the roads where the village boundaries follow roads) to the north-eastern corner of plot No. 83, Block B, Engomi, on a track : thence westwards along the southern side of the said track to the main road from the Nicosia-Troödos road bridge to the village of Engomi; thence south-westwards along the western side of the said main road to the most southern point of plot No. 186, Block C, Engomi, on a track ; thence westwards along the southern side of the said track, (crossing a road from the Nicosia-Troödos road to Kykko Monastery) to the south-western corner of plot No. 207, Block C, Engomi ; thence northwards along the boundaries of and including plots Nos. 207, 205, 204, 201, 200 and 194 of the said Block to the north-western corner of the said plot No. 194 on the Nicosia-Troödos main road ; thence westwards along the said main road in a straight line to the south-eastern corner of plot No. 71, Block Q, Ayios Dhometios, at a junction of roads: thence northwards along the western side of the road leading to the north-eastern corner of plot No. 69 of the said Block on the Nicosia-Myrtou main road ; thence westwards along the said main road to the south-eastern corner of plot No. 80, Block N, Avios Dhometios, at a junction of roads ; thence northwards along the western side of the road leading to the most northern point of plot No. 89 of the said Block at a junction of roads ; thence north-eastwards along the northern side of the road leading to the south-eastern corner of plot No. 126 of the said Block at a junction of roads; thence northwards along the western side of the road leading to the junction of roads at the north-eastern corner of plot No. 133, Block N, Ayios Dhometios; thence north-westwards along the southern side of the road leading to the cross-roads at the south-eastern corner of plot No. 164, Block B, Ayios Dhometios; thence northwards along the western side of a road to the southcastern corner of plot No. 53, Block H, Ayios Dhometios, at a cross-roads; thence eastwards along the northern side of a road to the cross-roads at the south-eastern corner of plot No. 51 of the said Block; thence northwards and north-eastwards along the western and northern side of a road to the most southern point of plot No. 3, Block K, Ayios Dhometios; thence northwards along the western boundary of the said plot to the road forming the southern boundary of the Nicosia Golf Course; thence eastwards along the northern side of the said road to the right bank of the River Pedieos; thence northwards along the said bank to the Cyprus Government Railway Bridge; thence castwards along the southern side of the said Railway to the western side of the road from the tannery near the Golf Course to the village of Trakhonas; thence north-eastwards along the western side of the said road to the point of commencement, all which said boundary is hatched in black on the Government Survey plan Serial No. 1256.
