Governor.

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Cyprus Pensions Orders and Laws, 1929 to 1941, and with the sanction of the Secretary of State, do hereby make the following regulations:—

1. These regulations may be cited as the Cyprus Pensions (Amendment) Regulations, 1943, and shall be read as one with the Cyprus Pensions Regulations, 1929 to 1941, (hereinafter referred to as " the principal Regulations "), and the principal Regulations and these regulations may together be cited as the Cyprus Pensions Regulations, 1929 to 1943.

2. The Second Schedule to the principal Regulations is hereby amended by the insertion therein immediately after the word " Ceylon " of the word " Dominica ".
