ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61. In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:— 1. This Order may be cited as the Defence (Returns of Stocks and Control of Raisins) Order, 1943.

2. In this Order-

Raisins" means boiled, scalded or sun-dried raisins produced in Cyprus,

but does not include sultanas.

3.—(1) Within four days from the date of the publication of this Order in the Gazette, every person who has in his possession or under his control any quantity of raisins in excess of one ton shall complete and deliver to me a return in the form set forth in the First Schedule hereto in respect of the raisins in his possession or under his control.

(2) Every person who at any time after the date of the publication of this Order in the Gazette becomes in possession or control of any quantity of raisins in excess of one ton shall, within four days of the date of his becoming in possession or control of such raisins, complete and deliver to me a return in the form set forth in the First Schedule hereto in respect of the raisins in his possession or under his control.

4. Not later than four days after the 15th day and the last day of every month, commencing from the month of November, 1943, every person who has in his possession or under his control any quantity of raisins in excess of one ton shall complete and deliver to me a return in the form set forth in the Second Schedule hereto in respect of the raisins in his possession or under his control.

5.-(1) From and after the date of the publication of this Order in the Gazette no person who has in his possession or under his control any quantity of raisins

in excess of one ton shall:

(a) consume or make use of; or

(1) in any way alter, treat, carry out any process in connection with or use in the preparation or manufacture of any liquid or article;

any quantity of such raisins whatsoever, save under a special permit issued under my hand:

Provided that nothing in this clause contained shall be deemed to prohibit

the cleaning or selection of raisins for the purposes of exportation.

(2) Every special permit issued under the provisions of sub-clause (1) hereof

may contain such terms and conditions as may be specified therein.

6. Every person shall permit such person as I or the Commissioner of the District may authorize in writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with or for the purpose of checking the correctness or accuracy of any return made under the provisions of this Order.

7. Any person who-

- (a) acts in contravention of, or fails to comply with, any of the provisions of this Order:
- (b) makes, under any of the provisions of this Order, any return which is false in any material particular;

(c) makes any false statement in any application for a permit under this Order; (d) fails to comply with any term or condition in any permit issued under

this Order;

(c) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61. In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This Order may be cited as the Defence (Haricot beans, Movement and Control) Order, 1943, and shall be read in conjunction with the Defence (Returns of Haricot

Beans) Order, 1943.

 For the purposes of this Order—
 "Haricot beans" does not include green haricot beans in the pod;
 "Local Purchases Officer" and "Producer" have respectively the same meaning as in the Defence (Returns of Haricot Beans) Order, 1943.

3. No person shall move or transport or permit or suffer to be moved or transported any haricot beans save under a permit given in writing by the Local Purchases Officer of the village in which the haricot beans have been grown and subject to such conditions as may be contained in the permit.

4. No producer shall sell, offer for sale, attempt to sell or make any arrangements to sell any haricot beans save under a permit in writing given under my hand and

subject to such conditions as may be contained in the permit.

5. Every person shall permit such person as I may authorize in writing in that behalf to enter and inspect his premises or property for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.

6. Any person who acts in contravention of the provisions of this Order or of any condition in any permit issued under the provisions of this Order or knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under this Order, is liable to the penalties prescribed in the Defence Regulations, 1940 to (No. 1) 1943.
