

No. 397. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

DELEGATION OF POWERS UNDER PARAGRAPH (5) OF REGULATION 66.

C. C. WOOLLEY,*Governor.*

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 1) 1943, do hereby depute the following officers to exercise and perform on my behalf the power to requisition drugs, proprietary medicines, chemical products, pharmaceutical preparations, sera and vaccines, surgical instruments, surgical supplies, surgical dressings, hospital appliances, medical appliances, opticals, dental instruments, dental appliances, dental materials, dental supplies, X-Ray films, X-Ray accessories, X-Ray appliances, X-Ray materials and laboratory equipment, and the powers connected with such requisitioning conferred by paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 1) 1943, which I am empowered to exercise and perform thereunder, that is to say:—

(1) The Controller of Medical Supplies.

(2) The Deputy Controller of Medical Supplies.

2. The delegation published under Notification No. 249 in Supplement No. 3 to the *Gazette* of the 2nd July, 1942, is hereby revoked, without prejudice to anything done or left undone thereunder.

APPOINTMENT OF COMPETENT AUTHORITY UNDER REGULATION 3.

I, the Governor, in exercise of the powers conferred by regulation 3 of the Defence Regulations, 1940 to (No. 1) 1943, do hereby appoint the Controller of Medical Supplies, to be a Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, in all matters relating to medical supplies, that is to say, drugs, proprietary medicines, chemical products, pharmaceutical preparations, sera and vaccines, surgical instruments, surgical supplies, surgical dressings, hospital appliances, medical appliances, opticals, dental instruments, dental appliances, dental materials, dental supplies, X-Ray films, X-Ray accessories, X-Ray appliances, X-Ray materials and laboratory equipment.

2. This appointment is in addition to, and not in derogation of, any other appointment made for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as a Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, and of every other power hereunto enabling, I hereby order as follows:—

1. This Order may be cited as the Defence (Revocation of Certain Orders Relating to Drugs) Order, 1943, and shall come into operation on the 22nd November, 1943.

2. The Orders set out in the Schedule hereto are hereby revoked without prejudice to anything done or left undone thereunder.
