## No. 408. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

## ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows :----

1. This Order may be cited as the Defence (Control of Sale Prices of Imported Articles) (Amendment) Order, 1943, and shall be read as one with the Defence (Control of Sale Prices of Imported Articles) Order, 1943 (hereinafter referred to S as "the principal Order"), and the principal Order and this Order may together be be cited as the Defence (Control of Sale Prices of Imported Articles) Orders, 1943.

2. Clause 11 of the principal Order is hereby amended by the addition thereto of the following sub-clause :---

"(4) If the Commissioner of the District is satisfied that any receipt or other acknowledgment given before the coming into force of this Order in respect of the sale of any imported goods is genuine, he may, by an endorsement thereon and subject to such terms or conditions as he may think fit to impose, declare such receipt or acknowledgment to be a price certificate and thereupon such receipt or acknowledgment shall be deemed to be a price certificate for all or any of the purposes of this Order, notwithstanding that it is not in the form provided in sub-clause (2) hereof."

3. Clause 28 of the principal Order is hereby amended as follows :----

 (i) by the deletion therefrom of paragraph (a) and the substitution therefor of the following paragraph:—
"(a) any imported article the sale price of which has been or shall be

(a) any imported article the sale price of which has been or shall be specifically fixed by or under any order under regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, and subsisting for the time being, made by me or by any other Competent Authority appointed by the Governor for the purposes of the said regulation; ";

(ii) by the addition thereto of the following paragraphs :---

" (e) the sale of used or second-hand articles of clothing sold by the owner thereof;

(f) any imported goods set out in the Third Schedule hereto."

4. The principal Order is hereby amended by the insertion therein immediately after clause 28 of the following clause :---

"Power to 28A. Notwithstanding anything in this Order contained, I may by exempt an instrument in writing under my hand and subject to such terms and conditions as I may think fit to impose exempt any person from the operation of clauses 10, 12, 18 and 27 of this Order or any of them."

5. The principal Order is hereby amended by the addition thereto of the following Schedule :--

"THIRD SCHEDULE-(Clause 28).

1. Postage stamps.

2. Newspapers, periodicals and magazines."
