

**No. 446. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.****ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Meat) (Bairam) Order, 1943.

2. The provisions of the Defence (Control of Meat) Orders, 1942 to (No. 2) 1943 shall not apply to the slaughter of animals or the sale or consumption of meat on the 8th December, 1943 (Qurban Bairam).

**No. 447. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.****THE CONTROL OF CATTLE AND MEAT ORDERS, 1942.**

In exercise of the powers vested in me by clause 6 of the Control of Cattle and Meat Orders, 1942, I hereby prescribe that the Mukhtar of any village may issue permits for the slaughter of cattle sufficient to provide, in addition to the usual quantity of 50 drams, a further quantity of 50 drams of carcas weight—

- (a) in respect of each Moslem inhabitant of the village during the period between the 8th December, 1943 and the 12th December, 1943; and  
(b) in respect of each Christian or non-Moslem inhabitant of the village during the period between the 22nd December, 1943 and the 26th December, 1943.

**No. 449. The Irrigation Divisions (Villages) Law, 1938.**

**IRRIGATION DIVISION OF PARAKKLISHA.****Rules.**

1. These rules may be cited as the Irrigation Division of Parakklisha (Amendment) Rules, 1943, and shall be read as one with the Irrigation Division of Parakklisha Rules, 1932, (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of Parakklisha Rules, 1932 and 1943.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words "one shilling" and the substitution therefor of the words "five shillings".
