No. 461. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.**ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as a Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Electrical Equipment) Amendment (No. 2) Order, 1943, and shall be read as one with the Defence (Control of Electrical Equipment) Orders, 1942 to 1943, (hereinafter referred to as “the principal Order”) and the principal Order and this Order may together be cited as the Defence (Control of Electrical Equipment) Orders, 1942 to (No. 2) 1943.

2. Clause 4 of the principal Order is hereby amended by the deletion therefrom of sub-clause (3) and the substitution therefor of the following sub-clause:—

“(3) Nothing in this clause shall apply to any of the articles described in the First Schedule hereto if such articles are held or used by any person for his reasonable domestic requirements.”

IRRIGATION DIVISION OF TRIKOMO-SYNGRASI.**Rules.**

1. These rules may be cited as the Irrigation Division of Trikomo-Syngراسي “Krina” Rules, 1943.

2. In these rules, unless the context otherwise requires—

“Commissioner” means the Commissioner of the District of Famagusta;

“Committee” means the Committee of the Irrigation Division;
