LIMITS OF THE MUNICIPAL CORPORATION OF NICOSIA. Notice under Section 6.

I, the Governor, in exercise of the powers conferred by section 6 of the Municipal Corporations Laws, 1930 to 1943, and of every other power hereunto enabling, do hereby order that the Notice published in Supplement No. 3 to the Gazette of the 7th October, 1943, under Notification No. 352, as amended by the Notice published in Supplement No. 3 to the Gazette of the 28th October, 1943, under Notification No. 375 shall be further amended by the deletion from the Schedule thereto of the words "Evghenia Theodotou Orphanage (plot No. 233, Block B, Ayii Omoloyitadhes); thence westwards along the southern boundary of the road from Ayia Paraskevi to the village of Ayii Omoloyitadhes to the most northern point of plot No. 60, Block B, Ayii Omoloyitadhes, on the main road from the village of Palouriotissa to the village of Strovolos; " (lines 45, 46, 47, 48 and 49), and the substitution therefor of the words:

'Nicosia Greek Community Orphanage (plot No. 233, Block B, Ayii Omoloyitadhes); thence westwards along the southern boundary of the road from Ayia Paraskevi to the village of Ayii Omoloyitadhes to the most northerly corner of plot No. 62, Block "B" Ayii Omoloyitadhes, Government Survey Plan No. XXI. 54. 2. IV at the fork roads; thence southerly along the easterly side of the road to the cross roads at the most northerly corner of plot No. 215 of the same Block, Government Survey Plan No. XXI. 54. 5. IV; thence southwestwards along the road to the fork roads at the most westerly corner of the said plot No. 215; thence north-westerly along the southerly side of the road to the road junction at the most northerly corner of plot No. 172, Block 'D' Ayii Omoloyitadhes, Government Survey Plan No. XXI. 54. W 2; thence southerly along the eastern side of the road to the most westerly corner of plot No. 175 of the same Block and plan; thence north-westwards along the road to the most southerly corner of plot No. 27 of the same Block and plan; thence in the same direction to the most westerly corner of the same plot; thence south-westerly to the most southerly corner of plot No. 139 of the same Block and plan; thence north-westerly along the southerly side of the same plot to its most westerly corner on the main road from Palouriotissa to Strovolos village;"

THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943. No. 472.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:-

1. This Order may be cited as the Defence (Quinine Control) (Amendment) Gazette: Order, 1943, and shall be read as one with the Defence (Quinine Control) Order, 1943, Supplement thereing the referred to as "the principal Order") and the principal Order and this Order may together be cited as the Defence (Quinine Control) Orders, 1943.

- 2. Clause 2 of the principal Order is hereby amended as follows:-
- (a) by the insertion therein immediately after the words "Deputy Controller" which appear in the second line thereof of a comma and of the words "Medical Supplies Control Officer ".

- (b) by the insertion therein of the following definition:—
 "Mepacrine" means Mepacrine Hydrochloride or Mepacrine Methanesulphonate tablets and ampoules thereof whether described as Atebrin, Quinacrine, or by any other trade name mark or designation.
- 3. Clause 6 of the principal Order is hereby amended by the deletion from sub-clause (1) thereof of the words "persons suffering from malaria" and by the substitution therefor of the words "such cases of malaria for the treatment of which the use of mepacrine is contra-indicated ".
