

No. 482. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.**DELEGATION OF POWERS UNDER PARAGRAPH (5) OF REGULATION 66.**

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 1) 1943, do hereby depute the Controller of Supplies to exercise and perform on my behalf the power to requisition any article imported into the Colony from any place outside the Colony, and the powers connected with such requisitioning conferred by paragraphs (1), (2), and (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 1) 1943, which I am empowered to exercise and perform thereunder.

No. 483. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.**ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**
