THE CYPRUS CURRENCY NOTES ORDER AND LAW, 1928 AND 1935, AND THE DEFENCE (AMENDMENT OF THE CYPRUS CURRENCY

NOTES ORDER AND LAW, 1928 AND 1935) REGULATIONS, 1942.

RULES MADE UNDER ARTICLE XV.

J. V. W. SHAW,

Acting Governor.

I, the Acting Governor, in exercise of the powers conferred upon the Governor by Article XV of the Cyprus Currency Notes Order and Law, 1928 and 1935, as amended by the Defence (Amendment of the Cyprus Currency Notes Order and Law, 1928 and 1935) Regulations, 1942, with the approval of the Secretary of State, do hereby make the following

1. These rules may be cited as the Cyprus Currency Notes (Amendment Short title. No. 2) Rules, 1943, and shall be read as one with the Cyprus Currency Gazettes: Notes Rules, 1942 and 1943, (hereinafter referred to as "the principal Supplement Rules"), and the principal Rules and these rules may together be cited No. 3: as the Cyprus Currency Notes Rules, 1942 to (No. 2) 1943.

2. Rule 26A of the principal Rules is hereby repealed and the Repeal of

following rule substituted therefor:-

"26A.—(1) In addition to the currency notes which may be issued the principal under rule 26 of these rules the currency notes of the denomination substitution of one shilling referred to therein may be cut into two portions of new rule. at a point immediately to the right of the reproduction of the King's. Head appearing on the face thereof, and the right hand portion over-printed as follows:-

(a) on the face-

(i) the figure "1/-" in the top right hand corner shall be ruled out and a figure "3" inserted alongside;

(ii) a figure "3" shall be inserted in the bottom right hand corner:

(iii) the words "one shilling" in Turkish shall be ruled out;

(b) on the reverse-

(i) a figure "3" shall be inserted in the top and bottom left hand corners;

(ii) the words "three piastres" in English, Greek and Turkish, and the date shall be inserted below one another; and issued as currency notes of the denomination of three piastres.

29.1.1942 18.2.1943 rule 26A of (2) The left hand portion of the currency notes cut under the provisions of paragraph (1) of this rule shall be destroyed in the same manner as cancelled currency notes under the provisions of rule 21 of these rules."
