THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE ACTING GOVERNOR.

Acting Governor.

I, the Acting Governor, in exercise of the powers conferred on the Governor by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1942, do hereby make the following regulations:-

1. These regulations may be cited as the Defence (Amendment No. 1) Regulations, 1943, and shall be read as one with the Defence Regulations, Gazettes: 1940 to (No. 9) 1942, (hereinafter referred to as "the principal Regu-Supplement lations") and the principal Regulations and these regulations may No. 3: together be cited as the Defence Regulations, 1940 to (No. 1) 1943.

- 2. Regulation 61 of the principal Regulations is hereby amended as follows :-
 - (a) by the deletion therefrom of paragraph (9) and the substitution tion 61.

therefor of the following paragraph:-

"(9) Any order made under paragraph (1) (ab) of this regulation may, in addition to any other penalty provided by these regulations, make provision, in the case of a contravention of the provisions of such order or the terms of a licence issued thereunder, for the vesting in such person as the order may direct of any articles to which such order relates which are in the possession or control of the person convicted of any such contravention and for the payment to such person of such sum in respect of such articles assuch person would be entitled to receive on a sale thereof under any order in force for the time being relating to the maximum price at which such articles may be sold or, if no such order has been made, for the payment to such person of an amount which the Commissioner of the District is satisfied represents a fair market price for such articles, less a percentage, in either case, not exceeding twenty per centum.":

(b) by the addition thereto immediately after paragraph (9) of the

following paragraph:-

"(§6) On a prosecution of a person for a contravention of any of the provisions of any order fixing or regulating the price at which any articles may be sold or purchased, when the sale or purchase and the price at which it was made have been proved, then it shall lie on the accused to prove that the price at which the sale or purchase in question was made did not exceed the price fixed or regulated by any such order".

3. These regulations shall be deemed to have been made and come into operation on the 26th day of February, 1942.

THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE ACTING GOVERNOR.

I, the Acting Governor, in exercise of the powers conferred on the Governor by the Emergency Powers (Defence) Acts. 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1942, do hereby make the following regulations:—

1. These regulations may be cited as the Defence (Control of Building Operations) (Amendment) Regulations, 1943, and shall be read as one with the Defence (Control of Building Operations) Regulations, 1942, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Defence (Control of Building Operations) Regulations, 1942 and 1943.

- 2. Regulation 2 of the principal Regulations is hereby amended as follows:—
 - (a) by the deletion therefrom of the word "and" which appears immediately after the figures "1938," in line 2 thereof;
 - (b) by the insertion therein immediately after the figures "1941", which appear in line 3 thereof, of the words "and the Summer Resorts (Development) Law, 1938,".
