ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as a Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This Order may be cited as the Control of Cattle Order, 1943.
2. In this Order—
“cattle” means bulls, cows, oxen, heifers and calves.
3. Within seven days of the publication of this Order in the *Gazette*, every person shall complete and deliver :
 - (a) in the case of a person residing in or carrying on business in a town, to the Commissioner of the district ;
 - (b) in the case of a person residing in or carrying on business in a village, to the Mukhtar of the village in which such person resides,

a return setting out the number of each of the following classes of cattle in his possession or under his control:—

(a) Bulls and oxen	1 year to 2 years.
(b) Cows and heifers	1 year to 2 years.
(c) Bulls and oxen	Over 2 years.
(d) Cows	Over 2 years.
(e) Calves	Under 1 year.

4. From and after the publication of this Order in the *Gazette*, no person shall sell or otherwise dispose of any cattle except under permit from the Senior Stock Inspector or Stock Inspector of the district in which the seller resides.

5. Within 3 days from the day on which any person sells or otherwise disposes of any cattle, such person shall furnish the Senior Stock Inspector or Stock Inspector of the district in which he resides with a statement in writing, setting out the name and address of the person to whom he has sold or otherwise disposed of such cattle.

6. Any person that I may authorize in writing in ~~that~~ behalf may enter upon any premises and make such enquiries or inspection therein as may be necessary for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.

7. Any person who—

- (a) contravenes or fails to comply with any of the provisions of this Order ;
- (b) makes a return or statement which is required to be made under this Order which is false in any material particular ;
- (c) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order,

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 1) 1943.

8. The provisions of this Order shall be in addition to and not in derogation of the Cattle and Meat Order, 1942.
