I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

- 1. This Order may be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) (Amendment) Order, 1944, and shall be read as one with the Minor State Forests Orders, 1942 to (No. 2) 1943, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to 1944.
- 2. The Schedule to the principal Order is hereby amended by the addition at the end thereof of the following areas:—

'21. Kondemenos in the District of Kyrenia:

All that area comprising plot No. 27 of Government Survey Plan No. XX.5E excluding a portion (63 donums approximately) at the north-western corner of the plot which lies west of the path leading from Ayia Marina to Kondemenos, between plots 18 and 20 of the same plan. The extent of the whole area is 24 donums approximately and is shown on Government Survey Plan Serial No. 1280.

22. Kambyli in the District of Kyrenia:

The area comprises (a) the whole of plot No. 204 of Government Survey Plan No. XI.36E comprising [29] donums approximately and (b) plot No. 205 of the same plan excluding 6 donums approximately at the northern corner of the plot, cut off by straight line starting at a point on the road to Sarayia being 50 feet south of the south-western corner of plot No. 198 of the same plan, thence north-easterly to a point on the road to Ktima situated 50 feet south of the north-eastern corner of the said plot No. 205. The extent of the whole area is 27 donums and 2 evleks approximately and is shown on the Government Survey Plan Serial No. 1281.

23. Keumurju in the District of Kyrenia:

An area of 14 donums approximately which is part of hali land plot No. 62 of the Government Survey Plan XII.42E at the locality 'Kma Aralar' the boundaries of which are as follows: The boundary commences on the road from Krini to Keumurju where it is crossed by a stream at a point of 80 feet due east of the main stream forming the village boundary of Krini and Keumurju and proceeds northeastwards up this stream for a distance of about 300 feet; thence south-eastwards for about 17 feet to the top of a slope; thence due eastwards for about 100 feet to the top of a rocky ridge; thence southwards along the said ridge to its end; thence southwards in a straight line to the road from Krini to Keumurju; thence southwestwards and north-westwards along the said road to the point of commencement. The area is shown on the Government Survey Plan Serial No. 1282."

- I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—
- 1. This Order may be cited as the Minor State Forests (Famagusta) (Amendment) Order, 1944, and shall be read as one with the Minor State Forests Orders, 1943, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Minor State Forests (Famagusta) Orders, 1943 to 1944.
 - 2. The Schedule to the principal Order is hereby amended as follows:—
- (a) by the deletion therefrom of the areas Nos. 9 and 10 (relating to the villages of Lysi and Kondea, respectively), and the substitution therefor of the following areas:—

Gazettes: Supplement No. 3: 7. 1.1943 26. 8.1943 "9. Lysi in the District of Famagusta:

A portion of Kouklia Reservoir at the locality 'Shiromandres' demarcated by boundary stones numbered consecutively from X6158 to X6165 and from X6173 to X6181, comprising 18 donums approximately and shown on the Government Survey Plan Serial No. 1283.

10. Kondea in the District of Famagusta:

A portion of Kouklia Reservoir at the locality 'Shiromandra' demarcated by boundary stones numbered consecutively from X6165 to X6173, comprising 16 donums and 1 evlek approximately and shown on the Government Survey Plan Serial No. 1283."

(b) by the addition thereto immediately after area No. 10 (relating to the village of Kondea) of the following areas:-

"11. Prastio in the District of Famagusta:
All that area at the locality 'Argaja' demarcated by boundary stones numbered consecutively from X6154 to X6157 being plot No. 39 of Government Survey Plan No. XXIII.61.E, comprising an area of 21 donums and 1 evlek approximately and shown on the Government Survey Plan Serial No. 1274.

12. Gypsos in the District of Famagusta:

A portion of hali land at the locality 'Trachonas' Ayios Elias, demarcated by boundary stones numbered consecutively from X6264 to X6289 (but excluding plot No. 1002 of the Government Survey Plan No. XIV.62), comprising 34 donums and 2 evleks approximately and shown on the Government Survey Plan Serial No. 1275.

13. Milea in the District of Famagusta:

A portion of the hali land at the locality 'Vikla' demarcated by boundary stones numbered consecutively from X6294 to X6312, comprising 29 donums approximately and shown on the Government Survey Plan Serial No. 1276.

14. Marathovouno in the District of Famagusta:
A portion of hali land at the locality 'Trachonas' demarcated by boundary stones numbered consecutively from X6182 to X6215 comprising 17 donums approximately and shown on the Government Survey Plan Serial No. 1277.

15. Angastina in the District of Famagusta:

A portion of hali land at the locality 'Moustafouri' demarcated by boundary stones numbered consecutively from X6146 to X6153, comprising 23 donums and I evlek approximately and shown on the Government Survey Plan Serial No. 1278.

16. Piyi in the District of Famagusta:
A portion of hali land at the locality 'Baharis' demarcated by boundary stones numbered consecutively from X6228 to X6255, comprising 42 donums and 2 evleks approximately and shown on the Government Survey Plan Serial No. 1279.

17. Peristerona in the District of Famagusta:

A portion of hali land at the locality "Bahari" demarcated by boundary stones numbered X6255, 6256, 6257, 6258, 6259, 6260, 6261, 6262, 6216, 6217, 6218, 6219, 6220, 6221, 6222, 6223, 6224, 6225, 6226, 6227, 6263 and 6228, comprising 38 donums and 3 evleks approximately and shown on the Government Survey Plan Serial No. 1279."
