

## No. 121. THE DEFENCE REGULATIONS, 1940 TO 1944.

## ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1944, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Oilburners) Order, 1944.
2. In this Order—

“Controlled oilburner” means any oilburner as may be specified in a notice published by the Conservator of Forests from time to time in the *Gazette*.

“Oilburner” means any device, wholly or partly manufactured in Cyprus, burning or consuming, or intended to be used for burning or consuming, oil fuel of any kind.

“Sell” includes—

- (i) any exposure for sale;
- (ii) any offer or agreement to sell;
- (iii) any attempt to sell;
- (iv) any arrangement to sell made either directly or indirectly.

3.—(1) From and after the date of the publication of this Order in the *Gazette* no person shall manufacture, sell or otherwise dispose of any controlled oilburner, without a licence from the Conservator of Forests.

(2) Any licence issued under this clause may contain such terms, limitations or conditions (including the mode of manufacture, form and structure of the oilburner, the method of distribution and sale price of the oilburner, and the affixture or impression of distinctive marks, words or numbers on the oilburner) as the Conservator of Forests may think fit to impose.

(3) A licence issued under this clause may be made valid for such period to be specified in the licence as the Conservator of Forests may think fit.

(4) The Conservator of Forests may at any time add to or alter the terms, limitations or conditions of any licence issued under this clause.

(5) A licence may be issued, refused or cancelled at the discretion of the Conservator of Forests:

Provided that any person aggrieved by the decision of the Conservator of Forests may, within ten days from the date thereof, appeal to the Governor in Council whose decision thereon shall be final and conclusive.

4. Every person shall permit such person as the Conservator of Forests may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.

5. Any person who—

- (a) acts in contravention of, or fails to comply with, any of the provisions of this Order;
- (b) fails to comply with any term, limitation or condition in any licence issued under this Order;
- (c) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order,

is liable to the penalties prescribed in regulations 61 and 94 of the Defence Regulations, 1940 to 1944.

## No. 122. THE DEFENCE REGULATIONS, 1940 TO 1944.

## ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as a Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1944, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Tree Felling) Amendment (No. 2) Order, 1944, and shall be read as one with the Defence (Control of Tree Felling) Orders, 1943 and 1944, (hereinafter referred to as “the principal Order”), and the principal Order and this Order may together be cited as the Defence (Control of Tree Felling) Orders, 1943 to (No. 2) 1944.

2. Clause 2 of the principal Order is hereby amended by the deletion therefrom of the words “Poplar” and “Walnut” appearing in the third line thereof and the insertion therein of the words “Olive” and “Carob”.
