**No. 128. The Irrigation Divisions (Villages) Laws, 1938 and 1944.**

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, the following rules made by the Committee of the Irrigation Division of Syrianokhori, in the District of Nicosia, are published in the *Gazette*.

**IRRIGATION DIVISION OF SYRIANOKHORI.**

*Rules.*

1. These rules may be cited as the Irrigation Division of Syrianokhori (Amendment) Rules, 1944, and shall be read as one with the Irrigation Division of Syrianokhori Rules, 1932 and 1938, (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of Syrianokhori Rules, 1932 to 1944.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the word "twelve" and the substitution therefor of the word "twenty".

**No. 129. THE DEFENCE REGULATIONS, 1940 TO 1944.**

**ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as a Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1944, I hereby order as follows :—

1. This Order may be cited as the Defence (Cheese Makers Control) (Amendment) Order, 1944, and shall be read as one with the Defence (Cheese Makers Control) Order, 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Cheese Makers Control) Orders, 1944.

2. Clause 3 of the principal Order is hereby amended by the addition thereto immediately after paragraph (2) of the following paragraph :—

"(3) A permit to make or manufacture cheese may be issued, refused or cancelled at my discretion."
