No. 152. THE POST OFFICE LAWS, 1881 TO 1933.

ORDER IN COUNCIL No. 2120
 MADE UNDER SECTION 6.

I, the Governor in Council, in exercise of the powers conferred by section 6 of the Post Office Laws, 1881 to 1933, do hereby order as follows:—

1. This Order may be cited as the Parcels Post (Rates of Postage) Order, 1944.

2. The respective rates of postage set forth in the Schedule hereto shall be charged by the Postmaster-General in respect of parcels posted in the Colony of Cyprus for conveyance to the places therein mentioned.

3. This Order shall come into operation from the date of its publication in the Gazette and thereupon the Parcels Post (Rates of Postage No. 2) Order, 1941, shall be revoked.

No. 154. LAND ACQUISITION LAWS, 1899 TO 1944.

Notice is hereby given that the following lands namely THAT portion of plot No. 226, Block A, Ibrahim Pasha Quarter, Nicosia, situated between the Neapolis locality, the Government of Cyprus Railway and the road from Nicosia to the village of Trakhonas, demarcated by white cairns numbered 1, 2, 3, 4, 5, 9, 10 and 11 are required by the Governor for an undertaking of public utility.
