No. 168. THE DEFENCE REGULATIONS, 1940 TO 1944.

DELEGATION OF POWER UNDER PARAGRAPH (5) OF REGULATION 66.

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to 1944, and of every other power hereunto enabling, do hereby order as follows:—

The Schedule to the Order published under Notification No. 545 in Supplement No. 3 to the *Gazette* of the 31st December, 1942, (relating to delegation of powers) is hereby further amended by the insertion therein immediately after the figure and words "6. Senior Stock Inspectors", which appear in the second column of the said Schedule, of the figure and words "6A. Deputy Controller of Agricultural Purchases".

No. 169. The Irrigation Divisions (Villages) Laws, 1938 and 1944.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, the following rules made by the Committee of the Irrigation Division of "Dytripas" Dam Pyla in the District of Larnaca, are published in the *Gazette*.

IRRIGATION DIVISION OF "DYTRIPAS" DAM PYLA.
Rules.

1. These rules may be cited as the Irrigation Division of "Dytripas" Dam Pyla Rules, 1944.

2. In these rules, unless the context otherwise requires—

"Commissioner" means the Commissioner of the District of Larnaca;

"Committee" means the Committee of the Irrigation Division;

"Irrigation Division" means the Irrigation Division of "Dytripas" Dam Pyla;

"Law" means the Irrigation Divisions (Villages) Laws, 1938 and 1944;

"list" means the list of the names and residence of the proprietors and of the lands and extent thereof which are to be benefited or are capable of being benefited by the works prepared under the provisions of section 15 of the Law as finally settled under the provisions of section 16 of the Law;

"works" means the irrigation works of the Irrigation Division.

3. The Committee shall hold office for a period of three years beginning on the 10th April, 1944. Thereafter the election of the Committee shall take place every third year in the first week of the month of April and it shall hold office for a period of three years from the day next following its election.

4.—(1) The Committee shall appoint a treasurer who shall collect the rates and charges assessed upon the proprietors mentioned in the list.

(2) The treasurer shall, on the 30th July in every year, prepare a statement of all rates or charges still due and unpaid on that date and shall forward such statement to the Commissioner.
