No. 177. THE DEFENCE REGULATIONS, 1940 TO 1944.

THE CONTROL OF CATTLE AND MEAT ORDERS, 1942.

In exercise of the powers vested in me under clause 6 of the Control of Cattle and Meat Orders, 1942, I hereby prescribe as follows:—

- 1. Except when specially authorized by me in writing, no Mukhtar shall, between Wednesday and the immediately following Sunday in any week, issue permits for the slaughter of cattle in excess of such number of cattle as will provide 100 drams of carcass weight in respect of each resident inhabitant of the village area in which the slaughtering takes place.
- 2. Notwithstanding the foregoing restriction any Mukhtar may, during any six consecutive months, issue to any resident inhabitant of his village a permit for the slaughter, between Wednesday and the immediately following Sunday in any week, of one pig for the household requirements of such resident inhabitant:

Provided that no permit for the slaughter of any pig shall be issued to any person under this clause:—

- (a) unless such pig has been in the possession of such person for not less than two months;
- (b) to more than one person in any household during the same period of six consecutive months, in which a permit has been issued to any other member of the same household.
- 3. Notification No. 361 published in Supplement No. 3 to the Gazette of the 7th October, 1943, is hereby cancelled without prejudice to anything done thereunder.
