# No. 188. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO (No. 2)1943.

#### ORDER IN COUNCIL No. 2123

MADE UNDER SECTION 116 (a) (i).

Authority to the Council of the Municipal Corporation of Kyrcnia to contract a loan.

- I, the Governor in Council, in exercise of the powers conferred by section 116(a)(i) of the Municipal Corporations Laws, 1930 to (No. 2) 1943, do hereby order as follows:—
- 1. That the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Kyrenia (hereinafter referred to as "the Municipal Corporation") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") the sum of two thousand five hundred pounds (£2,500) at a rate of interest not exceeding four per centum (4%) per annum subject to the following terms and conditions, that is to say,—

(a) that the sum borrowed shall be repayable by the Municipal Corporation to the Lender in twenty equal annual instalments (comprising sinking

fund and interest);

(b) that the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on the revenues the annual sum payable as aforesaid in the year to which such estimates relate;

 (e) that the sum borrowed shall be utilized by the Municipal Corporation for improvements to its domestic water supply;

(d) that the said improvements shall be carried out by, and under the control and supervision of, the Water Engineer to the Government of Cyprus.

2. That for the purpose of securing the repayment of the said sum of two thousand five hundred pounds the Municipal Corporation shall, subject to any prior mortgage thereon, mortgage to the Lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.

#### The Quarantine Law, 1932.

## NOTIFICATION UNDER SECTION 4.

In exercise of the powers vested in him by section 4 of the Quarantine Law, 1932, or otherwise, His Excellency the Governor is pleased to declare and hereby declares that the local areas in the first column of the Schedule hereto are infected local areas and that all passengers and goods therefrom shall, as from the date hereof, be subject to the measures prescribed by the Quarantine Regulations, 1932 to 1936, with rospect to the dangerous infectious diseases in the second column of the Schedule hereto.

The Notification No. 248, published in Supplement No. 3 to the Gazette of the

22nd July, 1943, is hereby cancelled.
