No. 20. THE ESSENTIAL WORKS ORDER, 1943.

ORDER UNDER CLAUSE 2.

Declaration of Essential Works.

H. M. FOOT,
Governor's Deputy.

I, the Governor's Deputy, in exercise of the powers conferred on the Governor by clause 2 of the Essential Works Order, 1943, and of every other power hereunto enabling, do hereby order as follows:—

1. The Order published in Supplement No. 3 to the *Gazette* of the 26th August, 1943, under Notification No. 308, (declaring certain works to be essential works for the purposes of the Essential Works Order, 1943), as amended by the Order published in Supplement No. 3 to the *Gazette* of the 16th September, 1943, under Notification No. 332, is hereby further amended by the insertion in the First Schedule thereto immediately after sub-paragraph (f) of paragraph 2 of the following sub-paragraph:—

“(g) All works and services in connection with the United Dyeing Works of Messrs. Christodoulou and Orphanides, Nicosia.”

No. 21. THE IRRIGATION DIVISIONS (VILLAGES) LAW, 1938.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, 1938, the following Rules made by the Committee of the Irrigation Division of Akaki (No. 2), in the District of Nicosia, are published in the *Gazette*.

IRRIGATION DIVISION OF AKAKI (NO. 2).

Rules.

1. These Rules may be cited as the Irrigation Division of Akaki (Village Water) (Amendment) Rules, 1944, and shall be read as one with the Irrigation Division of Akaki (Village Water) Rules, 1939, (hereinafter called “the principal Rules”), and the principal Rules and these Rules may together be cited as the Irrigation Division of Akaki (Village Water) Rules, 1939 and 1944.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the figure “10” (line 2) and the substitution therefor of the figure “20”.

Rules.

1. These rules may be cited as the Irrigation Division of Ayios Ioannis-Kato Mylos (Angoulos Dipotamia Water) (Amendment) Rules, 1944, and shall be read as one with the Irrigation Division of Ayios Ioannis-Kato Mylos (Angoulos Dipotamia Water) Rules, 1933 and 1934 (hereinafter referred to as “the principal Rules”), and the principal Rules and these rules may together be cited as the Irrigation Division of Ayios Ioannis-Kato Mylos (Angoulos Dipotamia Water) Rules, 1933 to 1944.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words “five shillings” and the substitution therefor of the words “ten shillings”.
