ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1944, I hereby order as follows:—

- 1. This Order may be cited as the Defence (Chick Peus, Movement and Control) Order, 1944.
 - 2. In this Order-

"Local Purchases Officer" means any person or body of persons whom I may appoint as such.

"Producer" means the owner or occupier of any land sown with chick peas

for the 1944 harvest.

- 3. Every producer in the districts of Paphos and Nicosia shall, on or before the 17th June, 1944, deliver to the Local Purchases Officer of the town or village in which the chick peas are grown a signed declaration setting out the number of donums of chick peas sown by him for the 1944 harvest.
- 4. No producer shall sell, offer for sale, attempt to sell or make any arrangements to sell either directly or indirectly any chick peas save under a permit in writing given under my hand and subject to such terms, limitations and conditions as may be contained in the permit.
- 5. Every person shall permit such person as I may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any application or declaration made by such person under the provisions of this Order.
- 6. The provisions of this Order shall not apply to chick peas grown in any town or village which may be exempted from the operation of this Order by a written notice under my hand to be posted up in a conspicuous place in such town or village.
 - 7. Any person who-
 - (a) acts in contravention of, or fails to comply with, any of the provisions of this Order;
 - (b) makes any false statement in any application for a permit under this Order;
 - (c) fails to comply with any term, limitation or condition contained in any permit issued under this Order;
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under this Order; is liable to the penalties prescribed in the Defence Regulations, 1940 to 1944.

No. 204. THE DEFENCE REGULATIONS, 1940 TO 1944.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1944, I hereby order as follows:—

- 1. This Order may be cited as the Defence (Agricultural Produce Movement and Control) (Amendment No. 2) Order, 1944, and shall be read as one with the Defence (Agricultural Produce Movement and Control) Orders, 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Agricultural Produce Movement and Control) Orders, 1944 to (No. 2) 1944.
- 2. Clause 2 of the principal Order is hereby amended by the deletion therefrom of the definition of the words "Agricultural Produce" and the substitution therefor of the following definition:—

"'Agricultural Produce' means wheat, barley, vetches, broad beans and oats".
