

## No. 242. THE DEFENCE REGULATIONS, 1940 TO 1944.

## ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1944, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Slaughter of Cattle) (Amendment) Order, 1944, and shall be read as one with the Defence (Control of Slaughter of Cattle) Orders, 1942, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Control of Slaughter of Cattle) Orders, 1942 to 1944.

2. The principal Order is hereby amended by the deletion of clause 2 and the substitution therefor of the following clause:—

" 2. Save under a permit in writing from the Chief Veterinary Officer or any person authorized by him in writing in that behalf or a member of the Police Force no person shall slaughter any cow or heifer or, being the owner, permit the slaughter of any cow or heifer or assist in the slaughtering or dressing of the carcass thereof or sell or expose for sale the carcass thereof unless at the time of slaughter the said cow or heifer had two or more fully grown permanent incisor teeth."

## ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.

1. This Order may be cited as the Defence (Control of Meat) (Amendment) Order, 1944, and shall be read as one with the Defence (Control of Meat) Orders, 1942 to (No. 2) 1942, (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Defence (Control of Meat) Orders, 1942 to 1944.

2. Clause 3 of the principal Order is hereby amended by the deletion therefrom of the word "Wednesday" and the substitution therefor of the word "Tuesday".

3. Clause 4 of the principal Order is hereby amended by the deletion therefrom of the words "or Wednesday".

4. The principal Order is hereby amended by the deletion therefrom of clause 5 and the substitution therefor of the following clause:—

" 5.—(1) No person shall on any Monday or Tuesday supply for consumption at or in connection with any establishment any meat, or any sandwich or dish containing meat.

(2) No person shall on any Monday or Tuesday consume in any establishment any meat or any sandwich or any dish containing meat.

(3) Not more than one plate or dish of meat shall be supplied for consumption at or in connection with any establishment to any one customer at any meal on any day on which meat may lawfully be supplied under this clause.

(4) In this clause ' establishment ' means any hotel, pension, hostel, restaurant, café, bar or any other place where food is prepared for sale or sold for human consumption."
