No. 249. THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

In exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, His Excellency the Governor is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Pyla, in the District of Larnaca.

SCHEDULE.

The boundary commences at the north-western corner of plot No. 54 of the Government Survey Plan No. XLI/2 locality "Aroahna" and proceeds north-eastwards along the boundaries of and including plots Nos. 54, 55, 42, 62 and 63 of the said plan, plot No. 141 of the Government Survey Plan No. XLI/10 and plot No. 182 of the Government Survey Plan No. XLI/11 to its most eastern point on a road from Larnaca to Pyla village; thence north-eastwards along the eastern side of the said road to the most northern point of plot No. 16 of the said plan; thence eastwards along the boundaries of and including plots Nos. 16 and 20 of the said plan to the most eastern point of the said plot No. 20 on a track, locality "Gypsha"; thence southwards along the said track including plots Nos. 20, 179, 180, 186, 187, 211, 210, 230, 235, 256 and 255 of the said plan, plots Nos. 3, 6, 9, 159, 158, 157 and 164 of the Government Survey Plan No. XLI/19 locality "Sermourise" to the most eastern point of plot No. 167 of the said plan; thence south-westwards along the boundaries of and including plots Nos. 306, 307, 308, 310 and 290 of the Government Survey Plan No. XLI/18 to the most southern point of the said plot No. 290 on the main road from Larnaca to the village of Pyla; thence north-eastwards along the eastern side of the said road to the north-western corner of plot No. 286 of the said plan; thence westwards and northwards along the boundaries of and including plots Nos. 248, 249, 237, 234 and 216 of the said plan, locality "Markantonias" and plot No. 95 of the Government Survey Plan No. XLI/10 to the western corner of the said plot No. 95 on a footpath; thence north-eastwards along the said footpath including plots Nos. 95, 100, 104, 105, 178 and 177 to the most western point of plot No. 177 of the said plan; thence north-westwards along the boundaries of and including plots Nos. 176, 157, 158, 172, 147 and 175 of the said plan, to the most western point of the said plot No. 175 on a footpath; thence north-eastwards along the said footpath to the most eastern point of plot No. 132 of the said plan; thence north-westwards along the boundaries of and including plot No. 123 of the said plan and plot No. 54 of the Government Survey plan No. XLI/2 to the point of commencement; all which said boundary includes an area of 2,465 donums or thereabouts as shown edged in red on the plan filed in D.L.R.S. M.P. 462/40.
