**No. 268. THE DEFENCE REGULATIONS, 1940 TO 1944.****ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1944, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Meat) (Suspension) Order, 1944.

2. The provisions of the Defence (Control of Meat) Orders, 1942 to 1944, shall not apply to the slaughter of animals or the sale or consumption of meat on the 15th August, 1944.
