- (b) any licence issued by the Council of the Municipal Corporation of Larnaca under the provisions of clause 3 of this Order shall cease to have any effect unless endorsed by the Controller of Transport;
- (c) upon the endorsement of a licence by the Controller of Transport under the provision of paragraph (b) above, such licence shall be deemed to be valid for the unexpired period thereof subject to any terms, limitations or conditions attaching thereto : Provided that the Controller of Transport may at the same time impose such further terms, limitations and conditions as to him may deem fit and such further terms, limitations or conditions shall be as fully valid and effective as if they had been imposed when the licence was first issued.

10^B. In this Order—

'Controller of Transport' includes any person authorized' by him for all or any of the purposes of this Order."

REGULATIONS MADE BY THE GOVERNOR'S DEPUTY.

I, the Governor's Deputy, in exercise of the powers conferred on the Governor' by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1942, do hereby make the following regulations :---

1. These regulations may be cited as the Defence (Perishable Goods) Regulations, 1944, and shall be read as one with the Defence (Perishable Goods) Regulations. 1943, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Defence (Perishable Goods) Regulations, 1943 and 1944.

2. Regulation 2 of the principal Regulations is hereby amended by the deletion from the definition of "Municipal Council" of the word "Larnaca,".
