No. 310. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1944.

ORDER MADE UNDER REGULATION 75 (1).

1. This Order may be cited as the Defence (Control of Lights) Amendment Order, 1944, and shall be read as one with the Defence (Control of Lights) Order, 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Control of Lights) Orders, 1944.

2. Clause 3 of the principal Order is hereby repealed and the following clause substituted therefor:—

“ 3. During an alert no light of any kind shall be displayed during the hours of darkness in any place in the Colony except inside a roofed building or other covered enclosure and then only in such manner that any illumination therefrom shall not be visible from outside the building or other covered enclosure.”
