No. 313. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1944.**ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 2) 1944, I hereby order as follows :—

1. This Order may be cited as the Defence (Control of Meat) (Suspension) (No. 2) Order, 1944.
2. The provisions of the Defence (Control of Meat) Orders, 1942 to 1944, shall not apply to the slaughter of animals or the sale or consumption of meat on the 19th September, 1944.

No. 315.**THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 AND 1944.**

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, the following rules made by the Committee of the Irrigation Division of Moutoullas, in the District of Nicosia, are published in the *Gazette*.

IRRIGATION DIVISION OF MOUTOULLAS.*Rules.*

1. These rules may be cited as the Irrigation Division of Moutoullas (Amendment) Rules, 1944, and shall be read as one with the Irrigation Division of Moutoullas Rules, 1933 and 1937, (hereinafter called “ the principal Rules ”), and the principal Rules and these rules may together be cited as the Irrigation Division of Moutoullas Rules, 1933 to 1944.
2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words “ ten shillings ” and the substitution thereof of the words “ thirty shillings ”.
