No. 316. THE CHANGE OF TITLES LAW, 1934.

**ORDER IN COUNCIL No. 2135
MADE UNDER SECTION 4.**

I, the Governor in Council, in exercise of the powers conferred by section 4 of the Change of Titles Law, 1934, do hereby order that the titles in the First and Second Columns of the Schedule hereto be added to the First and Second Columns respectively of the First Schedule to the Change of Titles Law, 1934, with effect from the 1st January, 1944.

No. 317. THE ELEMENTARY EDUCATION LAWS, 1933 TO 1944.

NOTIFICATION UNDER SECTIONS 42L (2) (a) AND 49A (a).

It is hereby notified that the 31st day of October, 1944, has been specified by His Excellency the Governor for the following matters under the Elementary Education Laws, 1933 to 1944, that is to say:—

- (a) as the last day for the exercise of the option under section 42L (2) of the said Laws for reduced pension and gratuity in the case of any teacher who has served not less than ten years and one month prior to the 1st day of January, 1944;
- (b) as the last day for the election under paragraph (a) of section 49A of the said Laws by any teacher whose name was on the 1st day of September, 1942 and the 1st day of January, 1944, on the Permanent Staff Register to come under the provisions of Part V of the said Laws and not under the provisions of Part IVA of the said Laws.

Provided that, with regard to any teacher who on the 6th day of January, 1944, was serving with His Majesty's Forces, the option and election hereinbefore mentioned may be exercised and made at any time within three months after his discharge from such Forces.

2. The Notification No. 37 published in Supplement No. 3 to the *Gazette* of the 10th February, 1944, is hereby revoked.
