# NOTICE No. 8 UNDER CLAUSE 2.

I hereby specify the following to be Controlled Oilburners for the purposes of the above Order:-

DESCRIPTION.

1.—(a) The oilburner called and known as the "GEYSER-STOVE" oilburner. (b) The "GEYSER-STOVE" oilburner is a gravity fed burner consuming all types of oil.

(c) The "GEYSER-STOVE" oilburner consists of the following parts namely:

Part (i) the hot-plate which is an ordinary circular cast-iron disc;

Part (ii) the bowl-tray in the shape of a bird-beak moulding revolving at a distance around a central point of origin;

Part (iii) the stand-flue which is a conical cast-iron tube serving the double purpose of supporting the device and producing a forced draught under the flame.

The oil is fed through a pipe into the bowl-tray where it is burnt the flames

impinging upon the hot-plate which acts as a spreader.

The "GEYSER-STOVE" oilburner is more particularly described in drawings

deposited with the Conservator of Forests.

2.—(a) The various models of the oilburners called and known as the "JUNIOR & BABY LAVA" oilburners.

(b) the "JUNIOR & BABY LAVA" burners are a gravity-pressure fed evapo-

rizer type oilburners consuming gas oil.
(c) The "JUNIOR & BABY LAVA" oilburners consist of a hollow cylindrical

preheating chamber, a jet and the connecting pipes. The oil is fed to the preheating chamber, where it is vaporized, the vapour passing through the connecting pipe to the jet, whence it issues and ignites, the flames being

directed through the hollow centre part of the preheating chamber.

The "JUNIOR & BABY LAVA" oilburners are more particularly described

in drawings deposited with the Conservator of Forests.

# No. 331. THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 AND 1944.

IRRIGATION DIVISION OF AYIOS THEODHOROS.

### Rules.

1. These rules may be cited as the Irrigation Division of Ayios Theodhoros (Amendment) Rules, 1944, and shall be read as one with the Irrigation Division of Ayios Theodhoros Rules, 1931 and 1936, (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of Ayios Theodhoros Rules, 1931 to 1944.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words "six shillings" and the substitution therefor of the words "eighty

shillings ". (M.P. 1021/31.)
