## THE POST OFFICE LAWS, 1881 TO 1933.

ORDER IN COUNCIL No. 2137

MADE UNDER SECTION 6.

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor by section 6 of the Post Office Laws, 1881 to 1933, do hereby order as follows:—

1. This Order may be cited as the Post Office (Air Mail Rate of Postage No. 3) Order, 1944.

2. There shall be charged a combined Postage and Air fee, in addition to late and/or registration fees, at the rates set forth in the third and fourth columns of the Schedule hereto, on letters, printed papers, commercial papers, samples, small packets and postcards intended for transmission by air mail to any of the countries of destination enumerated in the first column of the said Schedule, such transmission to be effected—

(a) by air or surface route from the Colony to Egypt or Palestine; and

(b) from Egypt or Palestine to the country of destination either wholly by air or partially by air and partially by surface route.

3. This Order shall come into operation on the 1st November, 1944 and thereupon the Post Office (Air Mail Rate of Postage No. 2) Orders, 1944, shall be revoked.

**No. 334. THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.**
