

No. 338. THE ELEMENTARY EDUCATION LAWS, 1933 TO 1944.

NOTICE UNDER SECTION 73 (1).

It is hereby notified that in exercise of the powers vested in the Governor by section 73 (1) of the Elementary Education Laws, 1933 to 1944, and otherwise, His Excellency the Acting Governor is pleased to direct and hereby directs that the additional tax mentioned in section 65 of the said Laws payable by the Mohammedan taxpayers of the towns and villages mentioned in the Schedule hereto shall be increased by the rate per thousand shown opposite the name of each such town or village to provide the amount required for the payment of loans or annual maintenance of the Moslem schools of the said towns and villages respectively.

No. 339. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1944.

ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 2) 1944, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Bakeries and Bread) (Amendment) Order, 1944, and shall be read as one with the Defence (Control of Bakeries and Bread) Orders, 1942 to (No. 2) 1943, (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Defence (Control of Bakeries and Bread) Orders, 1942 to 1944.
