No. 339. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1944.

ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 2) 1944, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Bakeries and Bread) (Amendment) Order, 1944, and shall be read as one with the Defence (Control of Bakeries and Bread) Orders, 1942 to (No. 2) 1943, (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Defence (Control of Bakeries and Bread) Orders, 1942 to 1944.

2. The principal Order is hereby amended by the deletion therefrom of clause 8 and the substitution therefor of the following clause :—

“ 8. Every registered baker shall keep in his bakery a book in which he shall enter or cause to be entered at the time hereinafter specified the following particulars :—

- (a) the actual amount of flour received with reference to the relative invoice numbers as soon as the flour is received ;
- (b) at the end of each day the daily quantity of sifted flour used for the preparation of bread ;
- (c) at the end of each day the daily quantity of bran extracted from the flour issued to him ;
- (d) at the end of each day the number of loaves of bread prepared or made or baked in his bakery ;
- (e) at the end of each month the stock in hand at the time.”

THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES) CONSOLIDATION ORDERS, 1940 TO 1942.

NOTICE No. 154 UNDER CLAUSE 13.

A.—The Schedule is hereby amended, with effect from the 26th October, 1944, by the deletion therefrom of Part 23 and the substitution therefor of the following Part :—

“ PART 23.—KEROSENE.

Definitions :

- (1) ‘company’ means any firm registered under the Defence (Control of Sale Prices of Imported Articles) Orders, 1943, as an importer of kerosene and any agent of such firm ;
- (2) ‘tin’ means a new sealed tin of 4 gallons capacity and must contain not less than 11 okes of kerosene ; the tin shall be deemed to weigh one oke.”

B.—The Schedule is hereby amended by the deletion therefrom of Part 30 and the substitution therefor of the following Part :—

“ PART 30.—IMPORTED OLIVE OIL.

In this Part of the Schedule, the term ‘wholesale’ means sale by Government Distribution Centres.”
