CUSTOMS LAWS, 1936 TO 1944.

ORDER IN COUNCIL No. 2140 MADE UNDER SECTION 52.

H. M. Foor,

Acting Governor.

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor in Council by section 52 of the Customs Laws, 1936 to 1944, do hereby order as follows :

1. This Order may be cited as the Import Duty (R.A.S.C./E.F.I. Goods and Stores) Exemption Order, 1944.

2. All goods and stores imported into the Colony by R.A.S.C./E.F.I. for the use of His Majesty's Forces or any other persons who under R.A.S.C./E.F.I. Regulations are entitled to the use thereof, duly certified as such by the Officer in charge of the R.A.S.C./E.F.I. in Cyprus or his deputy, shall be admitted free of any import duty. 3. This Order shall be deemed to have been made on the 1st day of January, 1944.
