No. 355. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1944.

ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 2) 1944, I hereby order as follows :—

1. This Order may be cited as the Defence (Intoxicating Liquor Manufacturers Control) Order, 1944.

2. In this Order—

“ factory ” has the same meaning as in section 2 of the Intoxicating Liquor (Manufacture) Licensing Laws, 1941 ;

“ manufacturer ” means any person licensed as a manufacturer under the provisions of section 3 of the Intoxicating Liquor (Manufacture) Licensing Laws, 1941 ;

“ intoxicating liquor ” means spirits and spirituous liquors of all kinds whether mixed with any other ingredient or not and whether coming thereby under some other designation, but does not include beer, zivania or wine containing less than forty two per centum of proof spirit.

3.—(1) Notwithstanding anything in any law or public instrument contained, from and after the 15th day of November, 1944, no manufacturer of intoxicating liquors shall manufacture or issue from his factory any intoxicating liquors save under a special permit issued under my hand upon a written application therefor.

(2) Every special permit issued under the provisions of this clause may contain such terms, limitations and conditions (including the quantity and description of intoxicating liquors to be produced and the price at which such intoxicating liquors may be sold or purchased) as may be specified therein.

(3) A special permit issued under this clause may be made valid for such period to be specified in the permit as I may think fit.

4. Every person shall permit such person as I or the Commissioner of the District may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.

5. Any person who—

(a) acts in contravention of, or fails to comply with, any of the provisions of this Order ;

(b) fails to comply with any term, limitation or condition contained in any permit issued under the provisions of this Order ;

(c) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order,

is liable to the penalties prescribed in the Defence Regulations, 1940 to (No. 2) 1944.

ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 2) 1944, I hereby order as follows :—

1. This Order may be cited as the Defence (Control of Sale of Coffee) Order, 1944.

2. In this Order—

“ coffee grinder ” means any person supplied by Government with coffee for the production of ground coffee ;

“ coffee ” means raw green coffee ;

“ mixed ground coffee ” means a mixture of roasted ground coffee and roasted ground barley or wheat bourgouri in proportion of 70% and 30% respectively.

3. From and after the date of the publication of this Order in the *Gazette* no coffee grinder shall manufacture or sell any coffee other than mixed ground coffee except under a special permit issued under my hand: Provided that nothing in this clause shall prohibit the roasting of coffee and of barley or wheat bourgouri separately, prior to the grinding.

4. From and after the date of the publication of this Order in the *Gazette* no person shall sell or dispose of for sale any ground coffee other than mixed ground coffee except under a special permit issued under my hand.

5. Every coffee grinder shall keep in his premises a register in which he shall enter or cause to be entered at the time hereinafter specified the following particulars :—

(a) the actual quantity of mixed ground coffee sold, as soon as the coffee is sold ;

(b) the name and the full address of the purchaser ;

(c) the date at which the transaction has taken place.

6. Not later than three days after the last day of each month, commencing from the month of November, 1944, every coffee grinder shall complete and deliver to me a return containing the particulars set forth in the Schedule hereto.

7. Every person shall permit such person as I, or the Commissioner of the District, may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.

8. Any person who—

(a) acts in contravention of, or fails to comply with, any of the provisions of this Order ;

(b) makes, under any of the provisions of this Order, a return or entry which is false in any material particular ;

(c) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order,

is liable to the penalties prescribed in the Defence Regulations, 1940 to (No. 2) 1944.
