**No. 366. THE DEFENCE CONTROL OF OILBURNERS ORDER, 1944.**

**NOTICE No. 9 UNDER CLAUSE 2.**

I hereby specify the following to be a Controlled Oilburner for the purposes of the above Order :

**DESCRIPTION.**

1. The oilburner called and known as the "IFESTOS" oilburner.

2. The "IFESTOS" oilburner is a vaporiser type oilburner consuming all kinds of oil.

3. The "IFESTOS" oilburner consists of a cylindrical preheating chamber with the original feed pipe passing directly through one side of the preheating chamber and discharging into the chamber through its inner wall at the opposite side.

The oil is gasified in the preheating chamber and is carried from the top of the chamber by a pipe, situated at right angles to the feed pipe, passing through an arc of 180° down the inside of the chamber and again coming through an arc of 180° upwards to a jet situated centrally to the preheating chamber.

The oil in the feed pipe is heated before reaching the preheating chamber by passing through the flame from the jet and the gas from the outlet pipe will also be atomised still further by this outlet pipe passing through the inner side of the preheating chamber on its way to the actual burner jet.

4. The "IFESTOS" oilburner is more particularly described in drawings deposited with the Conservator of Forests.
