No. 367. THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE ACTING GOVERNOR.

I, the Acting Governor, in exercise of the powers conferred on the Governor by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1942, do hereby make the following regulations:—

1. These regulations may be cited as the Defence (Trades and Industries (Regulation) Laws, 1937 and 1942) Regulations, 1944, and shall be read in conjunction with the Trades and Industries (Regulation) Laws, 1937 and 1942, (hereinafter referred to as "the principal Law").

2. Notwithstanding anything contained in the principal Law, all certificates issued in respect of any premises during the year 1943, shall, unless cancelled under the provisions of sub-section (5) of section 12 of the said Law, remain in full force and effect until the 31st December, 1945.

No. 368. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1944.

ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 2) 1944, I hereby order as follows:—

1. This Order may be cited as the Control of Cattle and Meat (Retail Prices) (Amendment No. 2) Order, 1944, and shall be read as one with the Control of Cattle and Meat (Retail Prices) Orders, 1943 and 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Control of Cattle and Meat (Retail Prices) Orders, 1943 to (No. 2) 1944.

2. Clause 2 of the principal Order is hereby amended by the deletion therefrom of the definitions of the words "kid" and "lamb" and the substitution therefor of the following definitions, respectively:—

"'Kid' means the meat of any goat having no permanent incisor teeth but does not include the meat of unweaned kid ;

'lamb' means the meat of any sheep having no permanent incisor teeth but does not include the meat of unweaned sheep."

No. 369. THE DEFENCE (HEATERS CONTROL) ORDER, 1944.

NOTIFICATION UNDER CLAUSE 3 (1).

In exercise of the powers vested in me under clause 3 (1) of the Defence (Heaters Control) Order, 1944, I hereby declare the 1st December, 1944, to be the date from and after which no person shall erect, use or work any wood burning heater of the following type without a licence from me, that is to say:—

Kilns for burning or baking tiles.
