

**No. 37. THE ELEMENTARY EDUCATION LAWS, 1933 TO 1944.****NOTIFICATION UNDER SECTIONS 42L(2)(a) AND 49A(a).**

It is hereby notified that the 31st day of July, 1944, has been specified by His Excellency the Governor for the following matters under the Elementary Education Laws, 1933 to 1944, that is to say :—

- (a) as the last day for the exercise of the option under section 42L(2) of the said Laws for reduced pension and gratuity in the case of any teacher who has served not less than ten years and one month prior to the 1st day of January, 1944 ;
- (b) as the last day for the election under paragraph (a) of section 49A of the said Laws by any teacher whose name was on the 1st day of September, 1942, and the 1st day of January, 1944, on the Permanent Staff Register to come under the provisions of Part V of the said Laws and not under the provisions of Part IVA of the said Laws.

**No. 38. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1943.****BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF FAMAGUSTA.**

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1943 and otherwise, the Council of the Municipal Corporation of Famagusta hereby make the following bye-laws :—

1. These bye-laws may be cited as the Famagusta Municipal (Amendment No. 1) Bye-laws, 1944 and shall be read as one with the Famagusta Municipal Bye-laws, 1940 to 1944 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Famagusta Municipal Bye-laws, 1940 to 1944.

2. Bye-law 142 of the principal Bye-laws is hereby repealed and the following bye-law substituted therefor :—

"142.—(1) The following rates shall be payable by the owner or occupier or lessee of any premises or buildings or place within the Municipal limits for the supply of town water by the Municipal Corporation :—

(a) in case of town water purchased from the Municipal Corporation, a rate of 20 shillings for every year ;

(b) in case of town water other than water purchased from the Municipal Corporation, a rate of 20 shillings for every period of six months.

(2) This bye-law shall be deemed to have come into force as from 1st January, 1944."

**IRRIGATION DIVISION OF KILANI.***Rules.*

1. These rules may be cited as the Irrigation Division of Kilani (Amendment) Rules, 1944, and shall be read as one with the Irrigation Division of Kilani Rules, 1932, (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of Kilani Rules, 1932 to 1944.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the figure "36" (line 3) and the substitution therefor of the figure "90".
