## No. 387. THE DEFENCE (CONTROL OF OILBURNERS) ORDER, 1944.

#### NOTICE No. 10 UNDER CLAUSE 2.

I hereby specify the following to be a "Controlled Oilburner" for the purposes of the above Order:—

#### Description.

- 1. The various models of Oilburner called and known as the "Sun-shine" oilburner.
- 2. The "Sun-shine" burner is of the self emergising type and consists of an oil feed pipe in two pieces leading on to two preheater chambers of closed domed structure, permanently joined together by a short length of pipe welded into them, the further one from the feed pipe being pierced on its upper surface by two small holes at an angle of 160° to each other at either side of an upright column carrying a dished plate spreader.
  - 3. The "Sun-shine" burner operates as follows:-

Primary heating is obtained by lighting a small fire of waste or similar material under the preheaters and when these are sufficiently hot oil is fed to them from the supply tank, the vaporized oil escapes through the two small holes on the main preheater and on ignition inpinges on the dished plate spreader which is supported by a small pipe fixed to the top of the preheater. This plate serves to deflect some of the heat generated back on to the preheaters for vaporizing the oil and also to deflect the flames of the apparatus from coming into direct contact with the bottom of the still or boiler in which the burner is working.
