

No. 54. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.**ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as a Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This Order may be cited as the Defence (Perishable Goods) Licensing Amendment (No. 2) Order, 1944, and shall be read as one with the Defence (Perishable Goods) Licensing Orders, 1943 and 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Perishable Goods) Licensing Orders, 1943 to (No. 2) 1944.

2. Paragraph (2) of clause 9 of the principal Order is hereby deleted and the following paragraph substituted therefor:—

"(2) The licence of any person convicted under the provisions of this Order may be cancelled by the Municipal Council which had issued the same or, in the case of the towns of Larnaca and Limassol, by the Controller of Transport."

3. The principal Order is hereby amended by the insertion therein immediately after clause 10A of the following clause:—

"10AA. With respect to the town of Limassol, notwithstanding anything in this Order contained, the words 'Municipal Council' whenever they occur in clauses 3, 4, 5, 6 and 7 of this Order shall be deleted and the words 'Controller of Transport' shall be substituted therefor."

No. 55.**THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES) CONSOLIDATION ORDERS, 1940 TO 1942.****NOTICE No. 134 UNDER CLAUSE 13.**

A.—The Schedule is hereby amended by the deletion therefrom of Part 28 and the substitution therefor of the following part:—

"PART 28.—SODA CRYSTALS (POTASSA).

7½ piastres per oke.	8 piastres per oke.	50 shillings per bag calculated on a basis of 70 okes.

In this part of the Schedule—

The term 'wholesale' means sale or purchase of soda crystals in quantities of not less than one bag of approximately 70 okes."

B.—The Schedule is hereby amended by the addition thereto of the following part:—

"PART 80.—SILKWORM EGGS.
